UPDATES ON COMERCIAL APPLICATOR RECERTIFICATION & NEW APPLICATOR TRAINING

There has been an update on the annual event training/recertification for commercial applicator's that is held in Casper January 20th - 22nd has a brand new name and look! The event will now be referred to as the Wyoming Applicator & Vector Education Summit (W.A.V.E.S.). The event will now incorporate more representation from the Wyoming Mosquito Management Association and other diverse topics within the world of invasive weed & pest management. This event allows new applicators an opportunity to learn crucial information that will be applicable to the C.O.R.E. manual exam that is taken by both private and commercial applicator's alike. The testing portion must be scheduled at any University of Wyoming Extension Office.

Those that currently hold Wyoming Commercial Applicator Licenses can take the time over the winter to attend and therefore earn CEC's (Continuing Education Credits) that go towards recertification. This also gives applicators the opportunity to refresh previous knowledge, recieve important updates, and learn

PRAIRIE DOG CONTROL UPDATES

The Laramie County Weed & Pest Offices do have Prairie Dog Rozol available for purchase November 1st - March 13th and Bait Machines available for rental. Please be aware that Prairie Dog Rozol is a restricted use product, meaning that it requires an applicator's license for purchase. We do not carry fumigant, but there are some applicator's in the area who can apply these types of control and those invoices can be turned into our office for partial reimbursement (please contact us for more information).

If you plan to purchase fumigant elsewhere, please be aware that there has been a rule change that now requires licensed applicator's to pass a 909 category test on fumigant.
